Bill was born on August 26, 1938, in Palmer, Massachusetts, and grew up in the Thorndike section of town. He was also involved in beagle trials for those years and was a member of the Palmer Beagle Club. While living in Newbury, Bill particularly enjoyed camping along the White River with his father, nephew Terry, and brother-in-law, Wayne to fish for trout and made a longer excursions, such as to the remote waters of Chibougamau in Quebec to fish for pike. He had several Brittany Spaniels over his later years for the purpose of bird hunting in the fields of the Upper Valley. In addition, Bill was a big Patriots fan but favored the Yankees over the Red Sox (to the chagrin of other family members)!

Bill's love of standardbred horses and racing began in his college years and the family's move to the farmhouse and 23 (or so) acres in Newbury, VT in 1974 enabled him to pursue this dream. He had numerous horses over the years, including such frequent winners as "Cambro Time" and "Swift River Connie." and he raced not only at racetracks throughout "the North Country," but at numerous fairs. He could always enthrall listeners with stories of photo finishes or of hazardous trips pulling the horse trailer through Sherburne Pass in Vermont or Crawford Notch in New Hampshire during snowstorms.

Bill was known for being outspoken and was always involved in politics and his community. This is evident both in his informal "holding court" while sipping cups of coffee at the Newbury General Store, engaging in debates from the seat of his pick-up as well as actually running for office and serving on local boards. The latter included a nine-vear stint on the Newbury Board of Selectman, several terms on the Oxbow School District Board and time as the Moderator at the Newbury Congregational Church, in which he and Bev were both active. Of course, there were also the informal, but always loud conversations that were a tradition at all family gatherings, such as at Thanksgiving or New Year's Eve, when Bill and his loving sister, Chris, would banter back and forth as the tv might be doing play-byplays of a Patriots game in the background.

Bill and Bev loved to travel and, especially, gravitated to historical sites including Gettysburg Pennsylvania and the Fortress of Louisbourg in Nova enjoyed Scotia. They camping at Wassampki Springs in Maine for many summers and spent numerous winters in Jensen Beach, Florida, where they relaxed on the beach, visited other retired friends, went out for seafood, or explored nearby environs such as Lake Okeechobee. There were also trips to England, Scotland and Wales as well as to the Gaspe Peninsula in Quebec and Canada's Maritime provinces.

One of Bill and the family's earliest adventures was the trip "out West" back in 1968 in a Ford Mercury that pulled a pop-up camper. Sites visited included the Badlands in

South Dakota, Yellowstone National Park, Zion and Bryce Canyon National Park, and the Grand Canyon. For many years afterward, the family would subject visitors to a slide show of the trip and such stories as when Bill and Larry hid from a curious bear in a campground bathroom.

However, both Bill and Bev loved the farm in Newbury above all else and the caring, supportive community of friends they had there throughout their 50 years in the town. Just as treasured as their many trips were quieter times spent in the kitchen, looking out the picture window to the field where a group of deer might be grazing at dusk.

Bill and Bev were both cribbage and rummy fiends and neither took prisoners when they played! Both would howl with frustration or gloat when they skunked each other or were caught in the "dead hole" at the end of a cribbage game. Bill also partnered with a friend and competed in local cribbage tournaments with an eye on the firsttrophies. Many place ended up on a table or shelf in the family room. Bill later continued to play cribbage and other games, attend plays or movies, and get in one last trip to Florida with his companion of the last two years—Joan.

Bill learned many carpentry skills from his father growing up and was also known for creative resourcefulness in dealing with problems. For instance, in his post-retirement years he remained busy on the farm growing and selling corn, pumpkins or other vegetables at various times. Needing plenty of water for this endeavor and with some summers being particularly dry, he set up a system for pumping water from the swamp at the edge of the property for this purpose. He'd also, at various times, raised some banty chickens for the purpose of making fishing lures, built a dog kennel in the back yard when living in Palmer and installed a system for rotating the roof antenna at the stone house

in Orford and then in Newbury in order to pick up a whopping two channels! This was in the days before cable or satellite tv, of course. Locals are also sure to remember days when Bill sold his corn from the back of "Old Blue" at a Route 5 pull-off down in Bradford, as well as when school groups picked his pumpkins from the field behind the Newbury house in the month before Halloween.

Bill is survived by his dear sister Christine Smith and his brother-in-law, Wayne Smith, of Palmer, MA; his nephew Terry Smith of Ware, MA and Terry's son, Evan; son Glenn Reed and his partner, Timothy Brennan, of Wilder, VT; son Larry Reed of Fair Haven, VT; granddaughter Devyn Reed of Pittsford, VT; granddaughter Brianna Thompson and her husband, Zach of Rutland, VT along with their two children, Eli and Norah; his companion Joan Ponzoni of White River Junction, VT; and many, many long-time friends in Newbury, VT and elsewhere. He was predeceased in 2020 by his wife of 54 years, Beverly Ellithorpe; and by his parents William J. Ellithorpe, Sr. (2007) and his wife, Madlyn (Kmon) Ellithorpe (2006), of Thorndike, MA.

A graveside service will be held at the Oxbow Cemetery in Newbury at noon on Sunday, October 27. This will be followed that day by a celebration of the lives of both Bill and Beverly in the Newbury Church Congregational vestry at 1 p.m. Both are open for family and friends, and all are invited to come and share stories/fond memories of Bill and Bev. 

She doesn't tell them that somebody's parents, who actually work to feed their families and pay their taxes, are going to get the tab for all those cupcakes after the party's over.







To the Editor,

David Rochefort and Joe Kenney in a recent opinion piece called upon us to rally in support of preserving the forest land of the North Country against the threat posed by Aurora Sustainable Lands of North Carolina and their carbon credit scheme which could significantly limit future logging there, putting both local jobs and tax revenue at risk. However, the North Country Democratic state reps Kelley, Cascaddin, and Noel, were on top of this issue from the get-go, sounding the alarm and sponsoring legislation to address it. But beyond this, these Democrats are also actively fighting even more major threats to local tax revenue - specifically the Republican fiscal policies that are causing our local property taxes to skyrocket. Here's how:

1) Reinstating the Republican-repealed Interest and Dividends Tax. This tax, which brings in over \$180 million to state coffers available for roads, bridges, schools, and government services, is set to be repealed a year from now. Re-

publicans want to let it die, while the Democrats have tried several times to restore it while coming up short. This tax only falls upon families making more than \$4,800 a year in interest and dividends from stocks and other investments. A New Hampshire Fiscal Policy Institute report finds that most of those benefiting from the repeal of this tax are in the top 1% income bracket with investments totaling between \$4 and \$13 million. The tax only starts accruing for households whose interest-producing investments grow beyond the quarter million dollar mark, not less. Those of us, however, in the North Country - the 99% who rely heavily upon state contributions to support our local municipalities - will have to make up the loss of state revenue available to our communities with a local property tax hike. Thus, Republicans like Rochefort, Kenney, and others, who support the repeal of the I & D tax, are causing our property taxes to increase while cutting wealth taxes for the rich. The Democrats are fighting to stop them.

2) Opposing Education Freedom Accounts. These Republicans support the EFA program, which takes public tax dollars away from the state's Education Trust Fund meant for our public schools and gives it to students who attend private, religious, and homeschooling forcing us taxpayers to increase our local property taxes to just keep those public schools afloat. The program was supposed to give low income students more options, but it is paying for from students families whose incomes are up to 350% of the federal poverty level, and Republicans keep trying to raise that eligibility cap. Meanwhile, 75% of EFA recipients were already paying for their attendance at private and religious schools before the program started. We taxpayers are, therefore, handing them money for an education they were already able to afford! Frank Edelblut. Sununu's Education Commissioner, who Kenney and Rochefort support, has championed this program, handing off oversight to a private company that the legislature can't even audit.

so we cannot see whether those tax dollars are being efficiently spent. In the meantime, our North Country public schools starve because we can't handle more property taxes, nor can we attract more community investment due to our lackluster schools. Moreover. because these Republicans support allowing wealthier communities, who collect more than they need for their own public schools' adequate education, keep from giving their fair share to the state to meet its constitutional obligation to adequately educate all New Hampshire students, we are forced to jack up our property taxes far beyond what they should be just to give our kids a mediocre one.

There have been several education funding forums given by experts dealing with this issue, like the New Hampshire School Funding Fairness Project, which conducted one such forum in SAU#36 just a week ago, organized at the suggestion of Democratic House Candidate Cathleen Fountain from Dalton. Seventy people attended, but surprisingly, not

one of the incumbent Republican candidates whose districts touch SAU#36! Not Seth King, not David Rochefort, not Sean Durkin, not Joe Kenney. Yet, rising local property taxes caused by inadequate funding of local public schools are the single biggest hurt experienced by taxpayers in the North Country, because New Hampshire, under Republican control, is dead last among the fifty states in state contributions to public education. Moreover, North Country Reps Rochefort, King, Davis, Mike Murphy, and Ouellet all voted to kill HB 1583 back in April, a bill that would have increased the level of state funding to public schools considered to be "adequate."

I'm running for re-election for the Grafton County Commissioner, District 2. As your current District 2 Commissioner I represent the residents of the towns of Bath, Benton, Bethlehem, Easton, Franconia, Haverhill, Landaff, Lincoln, Lisbon, Littleton, Lyman, Lyme, Monroe, Orford, Piermont, Sugar Hill, Thornton, Waterville Valley and Woodstock. I work jointly with the other two Grafton County Commissioners to serve as the County's Chief Executives providing oversight to the county's departments and budget.

The County Commissioners manage a budget of \$49 Million, with about \$26

million raised through local property taxes. I bring a good understanding of government budgeting having served as your County Commissioner for the last two years and on the NH House Finance Committee working on the state budget. And as a county taxpayer myself, I am a good steward of our tax dollars while supporting older adults, veterans, and families in Grafton County.

One of the main reasons I'm running for re-election is my interest in long-term care, particularly for older adults and making sure that our county nursing home provides the best care. I care that seniors and veterans have a choice of whether they want to get care at home or in our nursing home and that the care is high quality. Almost 23

percent of Grafton County residents are over the age of 65 which is considerably higher than the state average. My goal is to make sure that these residents have continued access to the health care and social services they need now and in the years to come.

To that end, I've worked with the Grafton County delegation and my fellow commissioners to reduce the amount spent on travel nurses by recruiting and retaining licensed nursing assistants at the nursing home with competitive wages while implementing a program to recruit licensed practical nurses. These initiatives have enabled the nursing home to better serve our county and significantly reduce the additional expense to pay travel nurses.

I also worked to adequately staff the County Department of Corrections by increasing the number of correction officers in the county department of corrections. Due to understaffing correction officers were working unsustainable extra schedules. Currently, the department has significantly reduced the openings for correction officers.

In the past term, the Commissioners used County ARPA money to help our towns, local non profits that serve older adults and those in recovery, and small businesses that struggled during the pandemic. And, we were able to bring in \$11 Million in federal dollars to build a middle mile broadband network to assist in bringing reliable internet service to rural parts of

Grafton County.

Affordable housing is an issue for the workforce and others in Grafton County and the Commissioners will provide ARPA money to our regional housing organizations to provide down payment assistance to low and moderate families trying to buy a home which will free up rental units for other individuals and families.

Whether it is long term care, broadband, or keeping your local property taxes stable, I am working for your interests in Grafton County.

I ask for your vote on November 5th. Thank you.

Hello hello my fellow chefs! How are you all doing today? I'm okay just adjusting to the very cool weather. We had a little hard freeze a couple of days ago so I brought all my plants in. They have gotten so big I really don't know where I'm going to put them all. It's supposed to warm up for several days so I think I'm going to put them back on the deck and try to figure out what I will do with them. There was a big beautiful full moon out the other night. On the news they said if you are lucky you could also see a comet. I guess I wasn't lucky because I couldn't find any comet. I checked for a few nights but other than the big moon and some stars I maybe I just wasn't lucky. center comes out clean. Hopefully maybe you were lucky enough to see it.

Let's get started with today's recipe and how to make it. I used 3 honeycrisp and 2 Granny Smith apples. They were on the big side but I used 5 to follow the recipe. If your apples are big I believe 4 large apples would have worked so use your judgment. It looks like a lot of apples but they shrink down.

Ingredients

5 apples peeled, cored,

sliced and cut into bite size pieces

2 cups of all purpose flour 1/2 tsp salt

- 4 tsp ground cinnamon
- 4 tsp baking powder
- 4 large eggs
- 2 cups white sugar
- 1 cup vegetable oil
- 2 tsp vanilla extract
- 1 cup chopped walnuts
- 4 tsp white sugar
- 1 tsp cinnamon

Preheat oven to 350 degrees. Grease and lightly flour a 9x13 baking dish. In medium bowl put flour, salt, cinnamon, and baking powder and whisk to mix well then set aside. In large bowl beat eggs and sugar together until all combined at least 5 minutes. Add oil mix well then add vanilla and mix well. Fold in apples and walnuts until all covered and combined. Pour into prepared baking dish. Mix the 4 tsp white sugar and 1 tsp cinnamon in small bowl then sprinkle over the top. couldn't find the comet. It Bake for 50-60 minutes wasn't totally clear so until toothpick inserted in

Mine took 60 minutes but check at 50 minutes. Cool on wire rack then cut with a serrated knife into squares as you use them. Serve with ice cream, yummy. You are done!!

Easy peasy and "Delicioso ". If you want you can cut this recipe in half and use a smaller baking dish and cut baking time. It makes a lot so you can share with your friends and neighbors. My wonderful friend and neighbor Diane let me use her oven and as it was baking the whole house smelled great. Yes I'm still without an oven!

Well folks that's it for today's recipe so please give it a try. It's a nice way to use extra apples. Your family will love it and say you are a star, enjoy!
