If you are not sure who they are, Google my N.H. State Representative and my State Senator (a map comes up, just click onto your town and the name of both come up with address) if you want the "Live Free or Die" State to prosper. Don't forget to encourage your family members and friends to do the same. By doing this we will be much closer to fulfilling the Nov. 5, 2024, Republican Mandate.



Under current law, New Hampshire statute allows unions to collect mandatory agency fees from employees in unionized workplaces even though some workers would opt not to join the union. Those not wanting to join the union, believe that all workers should have the right to decide whether to financially support a union or not.

Recently, the U.S. Supreme Court's decision in Janus v. American Federation of State, County and Municipal Employees, essentially shifted the workplace landscape by affirming that public-sector employees cannot be compelled to pay union fees, citing violations of First Amendment Rights. This 2018 ruling emphasized the importance of individual choice in the workplace, a constitutionally sound tenet of legislative process. the Based upon the Janus decision, public-sector employees in New Hampshire enjoy this right and cannot be forced to pay union dues; however, private-sector employees are not granted the same protections.

I believe that all employees, public or private, deserve the same level of fairness and fees or not. For this reason, it is unacceptable that some workers are still required to submit a portion of every paycheck to the union while others are not. Based upon this principle, HB238 was submitted to the Labor, Industrial, and Rehabilitative Services committee for consideration this past month. The bill prohibits collective bargaining agreements from requiring employees to join or contribute to a labor union. It is my belief that independent workers should have the right to work without having to pay a mandatory fee supporting the union's collective bargaining efforts.

HB238 will be acted upon by the full House on February 13. The bill recognizes the values unions provide in terms of wages, benefits, and training, but balances those attributes with the rights of all employees, union or nonunion members, to have the freedom to choose union membership or the right not to join the union. For these reasons, the majority of the Labor Committee has recommended Ought to Pass, 10-9.
